

END USER ACKNOWLEDGEMENT FOR PKP

By signing below, I acknowledge that I have FULLY READ AND UNDERSTOOD THE TERMS AND CONDITIONS of the Nondisclosure Agreement for **PKP_RUNSETS** ("**Agreement**") which the institute or entity to which I am affiliated ("**Recipient**") has accepted in order to allow me access to and use of the technical file "**PKP_RUNSETS**" ("Confidential Information") for non-commercial purposes limited to internal evaluation, testing and research purposes only. Defined terms in the Agreement shall apply to this End User Acknowledgement and shall have the same meaning.

I understand and accept that:

ACCESS AND USE

I shall use the Confidential Information exclusively for Internal Use strictly limited to non-commercial evaluation, testing, and research purposes, and to the extent expressly authorized by Discloser in writing.

I shall use the Confidential Information at the Recipient's premises and/or on the Recipient-provided facilities and equipment. I am not permitted to store, access, or transfer the Confidential Information on personal devices, unsecured networks, or cloud storage services not explicitly approved for this purpose.

I must use my official Recipient email account and secure channels for all communications related to the Confidential Information.

DISCLOSURE

I am not permitted to disclose the Confidential Information or any derivative to any third party, unless the Recipient first contacts Discloser through the designated administrator and obtains Discloser's prior written consent in each case of intended disclosure, such consent to be granted only through the formal application procedures designated by Discloser. Discloser reserves the absolute right to veto any request for disclosure and may exercise that right without providing any reason. Any collaboration with external parties that involves sharing Confidential Information — including, without limitation, technical exchanges, joint research, outsourcing, subcontracting, or commercial cooperation — shall be deemed a disclosure and requires separate prior written approval from Discloser.

Non-COMMERCIAL USE

I understand that the Confidential Information is provided for non-commercial use only. All intellectual property rights in or arising from any derivative works, improvements, inventions, patents, copyrights, know-how, or other results generated from or based on the Confidential Information shall automatically and exclusively belong to Discloser. Any commercialization, distribution, or other commercial exploitation of the Confidential Information or any such derivative results shall not be permitted.

COMPLIANCE

I will comply with all applicable security protocols and shall be subject to on-site compliance audits conducted by Discloser or Discloser's designated third party at least twice per calendar year.

Upon completion of my work/project/research, or upon my ceasing to be an employee or affiliate of Recipient, or upon the Discloser's request, I will immediately destroy all copies of the Confidential Information in my possession, including but not limited to all electronic files, documentation, notes, plans, and drawings.

Upon completion of destruction, the Recipient shall, within 7 business days, submit to Discloser a written certificate of destruction signed by an authorized representative, accompanied by verifiable records of the destruction process.
